**DEFENSE RELEASE, INDEMNITY, and
HOLD HARMLESS AGREEMENT**

As provided in Sections 1.0 and 2.0 of the Town of Oakboro’s Golf Cart and Slow Moving Vehicle Ordinance #TO-08004, any person operating a golf cart or slow moving vehicle on designated streets, roads, pathways, or highways within the Town of Oakboro’s jurisdiction, does so at their own risk and peril, and must operate said vehicles with due caution and circumspection and with regard for the safety and convenience of other motor vehicles , bicyclists, and pedestrians.

The undersigned owner and registrant hereby agrees to indemnify, defend and hold the Town of Oakboro, it’s officers, agents, servants, employees, assistants, legal representatives and their heirs, executives, executors, administrators, and assigns, completely harmless from and against any and all liabilities, losses, suits, claims, judgements, fines, or demands arising by reason of injury or death of any person or damage to any property, including all reasonable costs of investigation and defense thereof, including but not limited to, attorney fees, court costs, and expert fees, of any nature whatsoever arising out of an incident to the acts or omissions of the owner and registrant, it’s officers, agents, employees, contractors, subcontractors, subleases, licensees, invitees, or any third person in the use of the owner’s and registrant’s golf cart or slow moving vehicle, regardless of where the injury, death or damage may occur. I furthermore attest that I have received, read and understand the Town of Oakboro’s Rules and Regulations for Golf Cart/SMVs brochure.
